Minutes:

The Minutes of the 2009 Annual Meeting were presented for review. Dan Buckley motioned for approval of the Minutes as presented. The motion was seconded and unanimously approved.

President's Report:

MT-USAW President Dan Buckley expressed to the MT-USAW Body that there is concern about the number of wrestlers and how the Montana numbers are dropping. He encouraged the MT-USAW Community to pull together to increase the numbers. A healthy organization will increase our membership.

Dan also presented a proposal and recommendation from the E-Board that our Freestyle season be expanded. The E-Board suggests the following:

- Freestyle Season would begin January 15 and run through to February 4;
- Folkstyle Season would begin February 5 and run through to the end of March or at the conclusion of the MT-Open Tournament (date to be determined in Scheduling Committee);
- Freestyle would start back at the conclusion of the MT-Open and run to the end of the MT-USAW season.

The exception to this scheduling would be Kalispell. Rich Vasquez would like to schedule a Freestyle Tournament at the end of February in an attempt to attract wrestlers currently involved in the Little Guy Program in the Kalispell area. Rich would also contact USAW National Office and find out if they would become involved in promoting this event. The E-Board accepted this request.

Dan also spoke of how to try to generate interest for high school kids to go to the Junior & Cadet National Championships in Fargo. Steve Komac has suggestions for this and will comment further during his Cadets Report.

240 coaches went through the state rules clinic to be approved to coach at the USAW State Freestyle/Greco Tournament this past weekend. There were eight clinics this year, 6 by myself, one by Tim Webster and one by Jeremy Scheilds.

There were 11 adult official with a total of 21 officials at the same tournament to run 10 mats. In my opinion, this was by far the weakest officiated state tournament that Montana has ever seen. If each club would bring their mandatory adult officials, we would have had 13 more adult officials there which would have made a world of difference.

Somehow we need to prod our clubs to help produce those quality adult officials that are need to run a strong and successful tournament. Whether that be larger fines, or making that club ineligible for the team trouphy or I guess we just forget about it and ignore the problem. This is up to the general body to decise as there will be numerous proposals for change for our next season.

When I look at a corner during a tournament and see anywhere from 4-8 coaches, the red is almost blinding. I would hope this next season some of you take this serious and step up to help. It is a very legitimate concern for me and it should be for you as well. I appreciate the support you have given to myself and the state officials group. Give officiating a try... It is fun.

Pairing Report May 1, 2010

This year we had 13 new licenses and 31 renewals for a total of 44 licensed pairing masters, up from 33 last year. A few of the renewals the last couple years have been people who have been away for a few years but have returned to help. I guess the organization can't be too bad if they are willing to come back.

Please continue to consider the pairing needs when planning a tournament. Have all the paperwork and supplies that are needed. Allow enough time to get brackets ready and have people to copy and post charts before you start wrestling. Coordinate with whoever is in charge to be sure that your plan will work.

2010 USAW MT Kids Report

The 2010 State Freestyle saw a decline in participants with 470 wrestlers compared to 519 in 2009. The 2010 State Greco had 317 participants, up from 311 in 2009, increasing for the second straight year. The 2009 USAW Western Regionals in Pocatello again saw a huge growth in participation from Montana Wrestlers with 149 registered, up from 104 in 2008 and 86 in 2007. Montana had 138 register for Freestyle, 104 register for Greco, and 107 register for Folkstyle.

An attempt was made in 2009 to bring the 2010 and 2011 USAW Western Regionals back to Montana, but our State did not receive much support from the Region and Pocatello will once again hold this tournament for the next two years. Radical changes are being introduced to the registration process for Regionals, with singlet orders being done on line as well as registration being done through Trackwrestling.com.

The following proposals are to be put in place to help boost the number of adult officials within the Montana Freestyle/Greco scene.

- 1. Official's fines to be set at \$50 per missing officials. FAILS
- 2. Clubs who fail to provide the required number of officials {per standing rules} for said tournament would be eliminated from the team trophy race. MOTION PASSES 14/6
- 3. Coaches receiving a yellow card would be required to officiate the remainder of that tournament before being reinstated to coach. FAILS
- 4. Coaches receiving a yellow card would be required to officiate a full tournament before being reinstated to coach. FAILS
- 5. Coaches floor passes for Freestyle State Coaches floor passes will be allocated one per seven wrestlers. Two additional passes may be purchased per team. FAILS
- 6. Increase official's wages from \$5, \$6, \$7 and \$8 per hour to \$7, \$8, \$9 and \$10 per hour. Doing this will in hopes create more incentive to get other adults involved. FAILS
- 7. All coaches/officials rules clinics are free of charge except for the clinic at the state tournaments. The clinic at the state tournament will have a premium charge of \$10 cash per participant. MOTION PASSES.
